He speaking for the first time in Assam after the violent protests in December against the new citizenship law that left six people dead.

Amidst loud cheers and fluttering Tricolours and flags of the All Bodo Students Union, Modi asked the gathering — he called it the largest rally in independent India — in Kokrajhar in Bodoland Territorial Region to celebrate the peace and development accord that the government has signed with Bodo groups last month. Following the signing, over 1,600 members of the Bodo militant outfit NDFB laid down their weapons.

"I have come to assure people of Assam that the country will neither tolerate nor forgive anti-Assam and anti-India mentality and its supporters. These are the same forces who are spreading rumours in Assam and North-

चीन में महामारी का रूप ले चुके कोरोना वायरस से गुरुवार को और 73 लोगों की मौत हो गई जिससे मृतकों की संख्या बढ़ कर 636 पर पहुंच गई। साथ ही कोरोना वायरस से पुष्ट मामलों की संख्या करीब 31,000 हो गई।

चीन के राष्ट्रीय स्वास्थ्य आयोग ने शुक्रवार को बताया कि कोरोना वायरस से सबसे ज्यादा प्रभावित हुबेई प्रांत और उसकी प्रांतीय राजधानी वुहान में गुरुवार को 69 लोगों की मौत हो गई जबिक जिलिन, हेनन, ग्वांगडोंग और हैनान प्रांतों में एक-एक व्यक्ति के मारे जाने की खबर है।

आयोग ने बताया कि गुरुवार को 73 लोगों की मौत हो गई जबकि 3,143 लोगों के संक्रमण की चपेट में आने के नये मामले दर्ज किए गए। कोरोना वायरस की चपेट में आए मामलों की कुल संख्या 31,161 पर पहुंच गई है। उसने बताया कि गुरुवार तक संक्रमण से पीड़ित करीब 1,540 लोगों को इलाज के बाद अस्पताल से छुट्टी दे दी गई।

#### मरने वालों की संख्या 636 पहुंची

राष्ट्रीय स्वास्थ्य आयोग ने बताया कि 3,143 लोगों के संक्रमण की चपेट में आने के नए मामले दर्ज किए गए। कोरोना वायरस की चपेट में आए मामलों की कुल संख्या ३१,१६१ पर पहुंच गई है। गुरुवार तक संक्रमण से पीड़ित करीब 1,540 लोगों को इलाज के बाद अस्पताल से छुट्टी दे दी गई।

चीनी अधिकारियों ने बताया कि गुरुवार तक देश में रह रहे 19 विदेशी नागरिकों के कोरोना वायरस की चपेट में आने की पृष्टि हुई। हालांकि उन्होंने उनकी नागरिकता के बारे में खुलासा नहीं किया।

ब्रिटेन, जर्मनी और इटली ने चीन से कोरोना वायरस के नए मामलों की घोषणा की है, जिसके साथ ही यूरोप में इस वायरस से संक्रमित होने वाले लोगों की कुल संख्या 31 हो गई है। जर्मनी में दो मामलों को छोड कर सभी मामले वाहनों कलपुर्जों की आपूर्ति करने वाली कंपनी वेबेस्टो से जुड़े हुए हैं। इस कंपनी का मुख्यालय म्यूनिख के पास है, जहां इन संक्रमित व्यक्तियों का एक चीनी साथी गया था।

जर्मनी में कोरोना वायरस के जिस 13वें मामले की बायर्न स्वास्थ्य मंत्रालय ने घोषणा की है, वह वायरस के संक्रमण से पीडित एक कर्मचारी की पत्नी है। इस दंपति के दो बच्चे भी संक्रमण की चपेट में हैं। हालांकि, न बच्चों में और न ही उनकी मां में संक्रमण का कोई बाहरी लक्षण नजर आया है। इसके अलावा पिछले हफ्ते चीन से लाए गए दो अन्य लोग भी
