

CBI books Uitech founder in bribery case

UP re-invites online bids for 500 MW solar power

CLOSE ON THE heels of annulling a bidding for 1,000-MW power from grid-connected solar PV projects, the Uttar Pradesh and Renewable Energy Development Agency (UPNEDA) has re-invited online bids for 500 MW solar power through tariff-based competitive bidding.

The deadline to submit bids is August 28. The earlier bid was cancelled as the tariffs quoted by bidders were too high. "We decided to go in for re-bidding as we are sure of discovering lower tariffs in the range of ₹3.05/10/kWh," said Alok Kumar, principal secretary, Energy, government of UP.

Talking to UPNEDA said, "Instead of tendering for 1000 MW at once, we have split the capacity into two tenders of 500 MW each. By reducing the quantum, we hope to see better competition. Once the first tranche of 500 MW is auctioned, the commissioning time frame is 24 months."
