In compliance with the provisions of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, we would like to hereby inform that the Board of Directors ("**Board**") of the Company, at its meeting held on December 09, 2018, at 2nd Floor, DLF Centre, Sansad Marg, New Delhi – 110001, in relation to the proposed issue of equity shares to the existing shareholders of the Company on rights basis ("**Issue**"), has inter alia taken the following decisions:

- approved the Letter of Offer in relation to the Issue subject to the adoption of final Letter of Offer by the Securities Issuance Committee;
- approved the Issue of upto 3,45,48,560 (Three Crore Forty Five Lakhs Forty Eight Thousand Five Hundred and Sixty) equity shares having face value of Rs. 10/- (Rupees Ten only) each ("Rights Equity Shares") at an issue price of Rs. 72/- (Rupees Seventy Two only) per Rights Equity Share (including a premium of Rs. 62/- (Rupees Sixty Two only) per Rights Equity Share), on rights basis, aggregating up to Rs. 2487.50 million (Rupees Two Thousand Four Hundred Eighty Seven Million and Five Hundred Thousand only);
- fixed rights entitlement ratio at 4:5 ("**Rights Entitlement Ratio**"), meaning that the shareholders of the Company who are entitled to apply for the Rights Equity Shares ("**Eligible Equity Shareholders**") will be entitled to apply for 4 (Four) Rights Equity Share for every 5 (Five) equity shares held by such Eligible Equity Shareholders as on the record date:
